Cape Haze: A Great Place to Live

The residents of Cape Haze know that our Community is a beautiful, special place. Maintaining our quality way of life and our valued investments in our properties is important to us all. The Board of Directors of CHPOA has asked me to summarize some of the Charlotte County zoning regulations that are applicable and enforceable in our Community.

First of all, be a good neighbor and remember that what you do with your property can have a big effect on your fellow citizens. In particular, things like keeping your yard free of loose debris, your lawn and plantings well trimmed, avoiding leaving trailers in plain sight and keeping things in good shape set the tone for the whole Community. Also, please realize that not everyone appreciates your taste in music, so keep the noise down.

While these matters all relate to being a good neighbor, many are also covered in our County's zoning regulations which state that:

1. "Abandoned" vehicles, boats and trailers which are unlicensed, unregistered, and/or inoperable may not be kept on your property.
2. Trailers, boat or other types. may only be kept on your property behind the front and side setback lines.
3. Yards must be kept free of debris, trash or other yard waste.
4. No occupied RV's or house trailers may be kept on your property.
5. Accessory buildings are subject to the same setback rules that apply to permanent buildings.
6. Realtor "For Sale" or yard sale signs may not be placed on the "right-of-way", on trees or on

utility poles and **must be on your property.** The "right-of-way" is an area 25 feet from the center line of the road in both directions.

7. Yard sales may only run for two consecutive calendar days.
8. The circle at the fountain **must be rounded counter-clockwise**, i.e. **keep right**. Those who take a short cut by going left or clockwise around the circle are not only endangering themselves and others but are also in violation of state law.
9. Leaving cars or trailers on vacant lots which you do not own is also a violation of the law.
10. Excessive noise from musical instruments, radios etc or other loud sounds which disturb neighbors are in violation of Article V, Section 2-5 of the County Code.
11. Finally, Cape Haze is a residential area. The use of your home or your land for commercial activities is prohibited.

If you believe one of your neighbors is in violation of zoning regulations, the best approach is to discuss it calmly and rationally with them. You may also want to call Charlotte County Code Compliance to discuss it with them. They can be helpful in interpreting the codes and will step in to help correct a violation. These rules and regulations exist to protect our Community and our quality of life. Let us work together to keep Cape Haze the fine Community we all want it to be.

What Will Replace the Community Pool?

If you've visited the Community Center lately, you must be aware that our Community swimming pool was removed in January. That pool, dating from the earliest days of Cape Haze and nearly old enough to be eligible for Social Security, was no longer in compliance with new, more stringent county safety requirements. Since the costs for bringing the pool into compliance were prohibitive, the membership voted to remove the pool rather than rehabilitate it, as was reported in our last issue of *The Fountain*. Now the question remains how to best utilize the space it once occupied.

A committee of CHPOA members has been formed to research options for this space. Committee members are Art Hanson, Eva Furner, Clare Landmann, and Homer Hoe. An ancillary concern for the committee is how to reclaim the room in the Community Center building that was formally dedicated to pumps, filters, and other pool equipment. Successful integration of this room into the Community Center could offer approximately 100 square feet of useable common space.

Preliminary informal surveys of some CHPOA members have generated a wide range of suggestions for amenities that could be added to the outdoor space of the Community Center. Suggestions received so far include a smaller, heated swimming pool; planting areas flanking an expanded patio with more seating; a permanent outdoor bar/serving area near the kitchen; a water feature such as an artificial brook; a gazebo; a play area for children; and even a tennis court.

Over the summer, the committee will be working with local landscape architects and others to formulate design ideas and cost estimates for the options that appear to have the broadest appeal to the majority of CHPOA members. We will use the CHPOA website, www.capehaze.org, to post new information about the project as it becomes available. Click on the "Strategic Projects" link to learn the current status of our research.

We'd also like to hear your thoughts on the project as we go along. You may provide your input to the committee by visiting the "Strategic Projects" area of the CHPOA website. There you will find a link that allows you to download a form you can use for communication.

In the very near future, we hope to have the ability to allow direct, interactive input to the website itself. If you do not have internet access, please contact the committee chair, Homer Hoe, to pass along ideas.

Our timeline goal is to have a set of options and related costs ready for formal presentation to the community at the fall meeting of the membership in November. Ideally, the membership at our annual meeting in January, 2010, will approve one or more of the options for development.

Alligators are carnivores and eat anything from small insects to mammals. Did you know alligators cannot move their tongues? They swallow by raising their heads and using gravity. An alligator's bite has been measured at 3000 pounds per square inch. Males continue to grow as long as there is food and habitat to nourish them, averaging 10-15 feet long and 1000 pounds. They live 35-50 years and thrive in Florida.

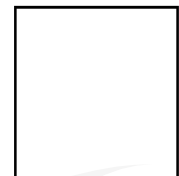
